MOBILE STAGE RENTAL AGREEMENT

TERMS AND CONDITIONS

1. The Bayfield Lions Club ("Club") agrees to rent their Mobile Stage ("Stage") to the Lessee and the Lessee agrees to rent the Mobile Stage on the terms and conditions of this Rental Agreement.
2. The Lessee agrees to pay the Club the full amount of the rental due on or before delivery on the set up date. Failure to pay the amount due in full will result in the return of the Stage by the Club.
3. Upon payment in full of the amount due, The Club will set up the Stage at the Event Site on the set-up date and will remove the Stage on the take-down date.
4. The Lessee shall ensure that the Event Site meets the following conditions: (1) a level and flat surface for set up of the Stage; (2) access to the Event Site and place of setup for the Stage are safe, easy and unobstructed, with no less than 12' of overhead clearance; (3) the Event Site and access to it, can support the weight of a 1 ton pick-up truck and a 3,500 lb. trailer. The Club or its member(s) delivering the Stage shall have the final determination as to what constitutes safe and acceptable conditions for access and set up of the Stage. If the Club or its member(s) delivering the Stage determines that the Event Site does not meet the above conditions, the Club shall not be obligated to set up the Stage and shall have the right to terminate this Agreement and under no circumstances whatsoever, including damages caused by, incurred by, resulting from, as a consequence of, or incidental to, any such termination. The Rental shall be returned to the Lessee in these circumstances.
5. The Lessee shall provide, at its own expense, the following on-site services: (1) Electrical supply equal to, but not in excess of the requirements of the Stage; (2) other items necessary to operate any of their own equipment.
6. The Lessee shall use the Stage in a careful prudent manner, in accordance with the specifications of the Stage and not for any unlawful purpose. Lessee shall use the Stage for its own use and shall not sublet or part with possession of the Stage or its chattels.
7. The Lessee shall obtain the approval of the Club or its delivering member(s) prior to the installation and/or hook up of any lights, sound systems, drapes or other Articles onto the Stage. No duct tape, masking tape or other type of adhesive substance shall be applied to any surface of the Stage.
8. The Lessee is not permitted to move or relocate the Stage from the place of set-up at the Event Site.
9. Title to and ownership of the Stage shall at times reside solely with the Club.
10. In the event the Stage cannot be delivered by the Club to the Event Site as a result of mechanical failure of the Stage or for any other reason, the Club shall have the right to terminate this Rental Agreement and as exclusive and sole damages, the Lessee shall receive return of the Rental Price paid by the Lessee.

11. The Club or its agent will prepare an inspection report at the time of set up in which all damage will be documented and signed by both the Lessee and the Club's agent. Should the Stage not be in the same condition in which it was rented out, the Club will be compensated by the Lessee for any damage done to the Stage during the rental period.
12. The Club, its designated agent(s), attendants and rightful claimants, will not be responsible for any material damage to third party property done by the Lessee, or any injury suffered or inflicted by the Lessee to themselves or others while in possession of the Stage.
13. Time shall be of the essence of the Rental Agreement and of every part hereof and no extension or variation of this Rental Agreement shall operate as a waiver of this provision.

Lessee acknowledges that it has read and understands this Rental Agreement, and hereby agrees to be bound by this Rental Agreement.
